**Parent Pledge Agreement & Fellowship Covenant**

**In making application to Romeoville Christian Academy, I understand the following:**

I agree to support the goal of Christian education at Romeoville Christian Academy: to assist parents in developing Christ-like, intellectually-equipped, community-focused, and well-rounded students by providing an excellent academic and extracurricular program within in a Biblical worldview.

**ACADEMIC GUIDELINES**

1. The administration of the school has the final responsibility for the grade placement of my child.
2. I agree to uphold and support the high academic standards of Romeoville Christian Academy by providing a place at home for my child to study and by encouraging academic responsibility.

**DISCIPLINE GUIDELINES**

1. The school reserves the right to dismiss any student who is found to be out of harmony with the rules and policies of Romeoville Christian Academy. Expulsion may result if students engage in conduct that violates biblical principles, dishonors God, or casts a poor reflection on the reputation of the school.
2. I believe that discipline is necessary for the welfare of each student, as well as for the entire school. I give permission for my child's teacher and/or agent of the school to make and enforce classroom regulations in a manner consistent with Christian principles.
3. The teachers and administration are hereby given full discretion in the discipline of my child. Disciplinary means may include demerits, assignments or duties, suspension, and expulsion.

**FINANCIAL GUIDELINES**

1. I understand that the Application/Testing Fee, Registration Fee and Student Fees are non-refundable.
2. It is my responsibility as a parent/guardian to pay a full year's tuition for each child enrolled as stated on the current financial information sheet, and late fees will be assessed if not paid by the due date.
3. I understand that students with delinquent accounts will not be allowed to participate in semester exams, graduations, and possibly could result in a suspension. I understand there is a withdrawal fee and that academic records will not be transferred to a new school until all outstanding fees and tuition have been paid in full.
4. In the event my account is submitted to collections, I assume the responsibilities of all charges incurred.

**GENERAL GUIDELINES**

1. I give Romeoville Christian Academy permission for my child to take part in all school activities, including school sponsored trips and sports activities. Should I have concerns about an activity, the concerns will be presented in writing to the administration for proper evaluation.
2. I absolve the school, its employees, and volunteers harmless from liability to me or my child at school or during school activities of any accidents that take place under reasonable supervision.
3. Should there be any questions or concerns involving the school, we agree to contact the teacher or administration, and I agree to follow the principles of Matthew 18:15-17, which says to go directly to the person with whom there is a difference and settle the difference before believers.
4. I will not go to the law before unbelievers (I Corinthians 6:1) for any reason, including injury and liability. I do agree to submit irreconcilable differences with the Academy to arbitration before mutually acceptable believers. I will not be critical of the administration or teachers in the presence of my child.
5. If a problem with the school cannot be remedied, we agree to quietly withdraw our child from the school rather than encourage discord or unrest among other parents.
6. I will regularly pray for and loyally support the faculty, staff, and administration of the Academy as they minister to the spiritual and educational needs of all enrolled students.
7. I understand that because RCA is a private school, I have no legal right to view my child's permanent records.
8. I will notify the school of any change in our address, employment status, contact information, or information regarding the health of my child.

**I understand that this is a legally binding agreement and that it cannot be altered by any party without the written consent of the other parties. I have read the above information and the School Handbook and agree to cooperate with Romeoville Christian Academy concerning these guidelines involving the education of my child.**
